Mr. Alexander shared that he is hopeful that a decision can be made in June or July.

9. Administrators' Report

9.1. High School

Mr. Sutter provided a handout on the school improvement program for the last five years at the high school. He shared information with the Board on how the school improvement process has improved over the course of this time and how these items relate to the strategic plan. This year the team has revisited the core values and beliefs, and made it their goal to have a clear mission statement. Mr. Sutter shared the specific ACT writing goal and was pleased to inform the Board that this goal was easily exceeded thanks in large part to the hard work by the English department. Mr Sutter stated that they have committed to the Marzano High Reliability Schools model and he shared the new programs/actions that they worked to implement this current school year based on the HRS survey data that was obtained.

9.2. Superintendent Report

Mr. Alexander shared information on LB670 and LB289 and the potential effect on schools and the Beatrice district specifically. He reminded the Board of the master facility meeting on May 14th. He informed the Board that the new bus is scheduled to arrive in mid July to early August and the balance due will be \$68,000. He stated that the district is in need of some new vans and he would like to discuss options for possibly packaging these items into a lease purchase agreement. He congratulated Mr. Randel for running a successful district track meet, Mr. Sutter for a top notch graduation ceremony, and the Beatrice Educational Foundation for their end of the year banquets/celebrations. Dates for the BEF's upcoming fundraisers were shared. Finally, all Board members were invited to the end of the year staff celebration at 3 PM on May 23rd.
