Mr. Alexander and Derek Aldrege, legal counsel representing Perry Law Firm, provided an update on the negotiation process with Johnson Controls. Discussion regarding this process ensued.

Upon the recommendation of the Board Chairperson and Agency legal counsel, and pursuant to the Nebraska Political Subdivisions Construction Alternatives Act, the Board of Directors for the Southeast Nebraska Education Agency should and does hereby terminate negotiations with the highest ranked construction manager, Johnson Control, Inc., for the proposed new PK-5 elementary school facility project for the reason that the Agency was unable to timely negotiate a satisfactory contract with such highest ranked construction manager, and further hereby authorizes, directs, and delegates to the Board Chairperson, or designee, and Agency legal counsel to negotiate a contract with the second highest ranked construction manager, Hausmann Construction, Inc., on terms and conditions deemed in the best interest of the Agency, and then, upon completion of such negotiation present all appropriate contract documents for contract adoption and approval by the Board passed with a motion by Brenda A McNiff and a second by Lisa Pieper.

The Board of Directors for the Southeast Nebraska Education Agency should and does hereby approve the general financing terms proposal for financing the new PK-5 elementary school facility as more particularly described on the terms sheet proposal, on file with official Agency records and as presented at this meeting, and further hereby delegates authority to and authorizes and directs the Board Chairperson, or a designee, to further negotiate general financing terms deemed in the best interest of the Agency, and to sign, execute and deliver the term sheet proposal or separate memorandum of understanding or intent, either with such terms or changes in terms as are deemed necessary and in the best interest of the Agency and approved by the Board Chairperson, and to prepare final financing documents to be presented and approved by the Board of Directors at a subsequent meeting passed with a motion by Brenda A McNiff and a second by Jon Zimmerman.
